ITEM NO. 800

FUEL SURCHARGE (Formerly CENF 100, Supplement 6)

Application of surcharge (See Notes A, B, C, D)

All charges for line haul transportation resulting from rates and/or charges, named in this tariff or contracts or other tariffs subject to this tariff, are hereby or will on their effective dates be increased as provided below.

In applying the provisions of this item, first determine the applicable line haul charge including all applicable and/or discounts, if any. The line haul charges so determined will be further subject to the surcharge provided herein. LTL = Less than 20,000 lbs. TL = 20,000 lbs or more. Net Line Haul charge is gross line haul charges less discount, if any subject to the Minimum Charge when applicable. It does not include accessorial revenue.

The net line haul charge will be subject to a fuel surcharge as provided below. The amount of the fuel surcharge will be determined by the National Average On-highway Diesel Price as provided by the U.S. Department of Energy (D.O.E.). The current On-highway Diesel Price may be obtained by calling 1-202-586-6966 (24 hours per day) or on the Internet at www.eia.doe.gov.

The National Average Weekly Retail On-highway Diesel Price published each Monday will be utilized to determine the applicable fuel surcharge, which will be adjusted up or down on the following WEDNESDAY based on the above referenced U.S. D.O.E. On-highway Diesel Price.

EXAMPLE: D.O.E. National Average On-highway Diesel Price published on MONDAY, 2-09-2015, will be used to determine the Fuel Surcharge which will become effective on WEDNESDAY, 2-11-2015.
